

How to read this notice

Attached is a copy of the Notice of Proposed Rate Change as required by the PUC. Please review this notice carefully, as it provides additional information about Texas Water Utilities' request and the processing of our application by the PUC. Below is more information outlining how to read and understand this notice for your service area.

Step 1: Locate your water or wastewater system on pages 6-9.

Water systems are listed on pages 6-8. Wastewater systems are listed on page 9. Systems are listed by county, and counties are listed in alphabetical order. If you are unsure of the name of your water or wastewater system, the neighborhoods served by each system are also shown.

Step 2: Once you have located your water or wastewater system, identify the codes that apply to you. (N/A indicates not applicable):

- Monthly Minimum and Gallonage Rates: The monthly minimum fee makes up the majority of most customers' bills and, for water, generally recovers the cost of system infrastructure that allows you to turn on your tap at any time and receive water. The gallonage rate generally recovers the variable cost of providing the water you receive and, for most systems, is tiered such that customers who use less water pay less per gallon. Similarly, the wastewater monthly minimum fee recovers the cost of the infrastructure while the wastewater gallonage charge, which is based on average winter usage for residential customers, recovers costs that are more variable and depend on actual wastewater flow.
- <u>System Improvement Charge:</u> The system improvement charge is a rate based on meter size that is currently added to your monthly bill to recover the cost of system improvements. Texas Water Utilities proposes to include the current system improvement charge for all systems in the base rate.
- <u>Passthroughs</u>: A passthrough rate is a rate added to your monthly bill to recover the cost of purchased water or purchased wastewater treatment.
- <u>Federal Tax Change Credit Rider:</u> This monthly credit from the Federal Tax Cuts and Jobs Act of 2017 passes estimated savings to customers of the Hornsby Bend system. Texas Water Utilities proposes to eliminate the credit, as the estimated savings previously included in the credit will instead be rolled into the calculation of the proposed monthly minimum and gallonage rates.
- <u>Docket 50944 Interim Rates Reconciliation Surcharge/Surcredit:</u> This surcharge/surcredit reconciles the "interim" rates charged by Texas Water Utilities while the PUC reviewed its last rate application. It is applicable only to customers of systems that were part of Texas Water Utilities' last rate application. The current rate application has no effect on these rates.



Step 3: Refer to pages 10-35 for a comparison of current and proposed monthly minimum and gallonage rates, as well as miscellaneous fees charged only on a case-by-case basis (e.g., returned check charge or meter relocation fee). Rate schedules are listed by corresponding code and also list the system(s) served.

Step 4: Refer to pages 36-37 for comparisons of corresponding charges or credits added to the monthly bill. Note that amounts in parenthesis are credits.

^{*}A <u>protest</u> allows customers to provide comments to help inform the PUC's decision making during the rate review. A <u>request to intervene</u> makes a customer a party to the rate case. Customers electing to intervene may be required to attend PUC hearings and asked to provide evidence, as well as testimony.

The proposed rates will apply to service received after the effective date provided below, unless modified—or suspended by the Commission. If the Commission receives a sufficient number of protests, separately or in a combined protest letter, from at least 3,936 ratepayers (10 percent of the utility's customers over whose rates the Commission has original jurisdiction) or from any affected municipality before the 91st day after the proposed—effective date, the matter will be set for hearing. See Protest Form on the next page for instructions on how to protest.
